Once approved, loan proceeds will be immediately available to the borrower. Repayment of principle and interest begins as soon as the loan is disbursed. 11. Automatic Savings Accounts

Financial planning can include saving accounts. Several banks, including Wachovia and Bank of America offer automatic savings accounts where funds from your checking account are automatically transferred into the consumer's savings account. The amounts transferred can be a much or as little as you like, but it all adds up. As an example, Wachovia's program called "Way 2 Save," transfers \$1 to your savings account anytime you use your debit or check card or any time a bill is paid online. Bank of America's plan rounds purchases up to the nearest dollar and transfers this amount to your savings account. Ask your local bank to see if they have a similar program, or open a new account at a participating bank and start putting money away for an adoption.

This foundation provides matching grants and fundraising assistance to offset the cost of international adoptions. Bringing together orphaned children with married Christian couples who are starting or expanding their families.

22. Federal Adoption Tax Credit

www.irs.gov/taxtopics/tc607.html The United States offers a Federal Adoption Tax Credit which can be used to offset the cost of adoption for qualifying families. The amount of the credit, terms, and eligibility has historically changed from year to year. In general, the tax credit is designed to offset necessary and reasonable adoption expenses such as adoption fees, court costs, attorney's fees and travel expenses. Of course, income limits and other rules apply. It is recommended you consult your tax advisor to evaluate your individual situation. Before paying for adoption related expenses, consider who will be filing the tax return. All checks should be written by that tax payer. Jointly filed returns will not encounter this problem.

In 2012, the Adoption Tax Credit was made permanent. Currently, adoption Tax Credit Amount are as follows: 2011: \$13,360 (refundable) 2012: \$12,650 (non-refundable) 2013: \$12,970 (non-refundable). The Adoption Tax Credit was refundable only through 2011. Unused credit may be carried forward up to five tax years. Effective December 5, 1991, a permanent adoption reimbursement program for active duty members of the military services was established. The program is for active duty Service members incurring adoption expenses for a child under age 18 years. The member may receive reimbursement for qualifying expenses, up to \$2,000 per child. Couples, where both spouses are active duty service members, may not receive program reimbursement totaling more than \$5,000 in any calendar year. Eligible Active duty services members can service in all branches including US Coast Guard, and commissioned officers of the Public Health Service and the N.O.A.A.

The Department of defense has an official instruction (DoD Instruction number 1341.9) outlining the reimbursement policy, and leave guidelines. Recent legislation provides for an allotment of non-chargeable leave for 21 days, for service members adopting a child.
